Passing of the Minutes

1. Motion to pass Senate Meeting #11 minutes. Motion passes, 15-3-0

Reports

1. Alfonso Di Rocco and Joel De La Cruz | USS Delegates

- a. Alfonso: We had our second meeting on Sunday, November 29th. During the first meeting, we had the transition of our chairperson, which is most likely why there was a delay in our USS preliminary meetings since they're usually month to month. Currently, we have 8 of the 9 positions on the steering committee filled. There are 2 candidates that compete for each position, and so they need 29 votes to win the majority. It was difficult to get the majority of 29 votes. Because we are still missing the vice-chair of fiscal affairs, we are having an emergency meeting this Sunday, December 6th, because we have not been able to do anything fiscally until the position gets filled. In terms of candidates, we have Joel and Alexis Fisher from Hunter College. During this last meeting, we had 2 resolutions passed unanimously.
- b. Joel: One resolution that was passed was the one concerning the Credit/No Credit policy that's going to
 be sent to the Faculty Senate and the Board of Trustees. The second was a core craft-related resolution.
 We asked the Board of Trustees to consider the continuation of the Credit/No Credit policy as they did in

the previous semester and to continue the protections that they set in place. For example to protect students from GPA requirements for a class that they take credit with and similarly with letter grades of systems. For those who aren't aware, Core Craft is a New York State program where inmates who volunteer at federal state prisons in New York work jobs in a manufacturing role and they sell these products. Under New York state law, Core Craft is only legally allowed to sell its manufactured products to the state government and state agencies. Public Schools, such as universities in high schools, are also eligible to purchase these items. Earlier in the pandemic when there was a panic for hand sanitizer and Cuomo had come out making a New York hand sanitizer to bring down its prices by meeting with those in charge of increasing supply. These hand sanitizers were created through the Core Craft program. Many of the delegates noticed and didn't like the idea that we were getting hand sanitizer from this program and this resolution, in essence, says that we ask that CUNY disinvest from Core Craft and related products and not purchase them in any capacity. As Alfonso did mention, after passing the Credit/No Credit resolution, we did receive recognition for the meaning of the signatures and testimonies we sent.

- c. Alfonso: With the upcoming election this Sunday, I'm supporting Joel with his outreach for his candidacy. Typically there are 50 to 60 delegates for each election that must vote. Recently I was appointed to the Board of Trustees audit committee as a Student Alternate so that position deals with contracts that CUNY is involved in and seeking if we want to continue this contract. I believe we meet around 3-4 times a year. At the last one, we went over a resolution to update the standards for privacy across CUNY as a whole because CUNY is a type of financial institution that needs to meet certain requirements. We had to improve the implementation of updating the system, the first time in 6 years. Furthermore, the upcoming steering committee members are receiving notice of which vice-chairs are heading which committees. With the 9 committees, plus an additional 2-4 subcommittees, each delegate is required to participate in at least 2 of them. Credit/No Credit is not absolute with CUNY. We have seen City College implement its own, but it is difficult for individual colleges to put those policies through, so it would be much smoother for CUNY as a whole to pass it through. Joel and I personally are looking into changing the chronological setup of the USS bylaws, which we worked on with multiple USS delegates last Sorig after the Albany trip so that this type of overlap doesn't happen each year, to better prepare each following term of successors to have an easier and smoother transition. - d. Briana: Congrats Alfonso on your new position, and good luck Joel with the election.
- e. Alfonso: Tomorrow, December 2nd, CUNY rising alliance is having a virtual town hall from 7 PM to 9 PM about the proposed legislation for a new deal for CUNY, which is an organization that USS works with closely, and works towards making CUNY more affordable and tuition-free so feel free to come by.
