### Reports

- 1. Elections
  - a. Viewing of the video submissions. Topics that are covered include, "Who are you and a fun fact? Why do you want to be a representative senator? In this virtual environment, what are some things USG has done well and can improve on? What is one initiative/event you would like to implement?"
    - i. Polina: I want to be a representative senator because I want to be more involved in school and believe that being a part of USG will allow me to do so. There are certain changes I would like to see around the school and I believe this role will give me the platform to make those changes a reality. Fun fact about me is that I enjoy baking. In this virtual environment, one thing USG has done well is their persistence in engaging with the students through online events, and having the USG representative go live during quarantine and showcasing their skills to the student body. One thing USG can improve on is that there is not enough awareness about different opportunities at school, and perhaps they can create virtual meetings to spread the word on what is going on to the students. - 2. Richard Reyes | VP of Legislative Affairs
  - a. Richard: Just a little disclaimer; I am feeling a little under the weather. Today I'm going to be presenting a resolution to enact a Credit/No Credit Policy for Baruch College for the Fall 2020 semester. If this report is passed, we will be emailing this to the President and Baruch administration as well as a 37 page report that myself and Laiba have been working on which showcases students' opinions on how they're doing with respect to education and their well-being given the COVID pandemic. We've also gathered key statistics for another 22 page report.
    - i. WHEREAS, Governor Cuomo of New York State announced the shutdown of ALL SUNY and CUNY campuses, as of 03/19/20; AND
      - 1. Statement changes: none.
        - a. Passes.
    - WHEREAS, "the Covid-19 Flexible Grading Policy was designed in consultation with CAMPUS PRESIDENTS and DEANS, the University Faculty Senate, the University Council of Registrars, and the University Student Senate to provide students with maximum flexibility during the ongoing and challenging transition of all courses to distance learning;" AND
      - 1. Statement changes: none
        - a. Passes.
    - iii. WHEREAS, an extensive survey conducted by Undergraduate Student Government at Baruch College spearheaded by Richard Reyes: Vice President of Legislative Affairs in collaboration with Laiba Hussain: Chair of Public Opinion found overwhelming data and metrics that align with the notion that distance learning is not at the capacity that of which Chancellor Felix V. Matos Rodriguez highlights; AND

    - iv. WHEREAS, such survey indicates the lack of data that both CUNY and Baruch College have failed to administer on their end, where such survey denotes the effects of Covid-19 in relation to education and wellbeing as of present time; AND

    - v. WHEREAS, the Chancellor has the discretion to review and extend the policy as necessary to meet public health emergency policies and practices; AND

    - WHEREAS, as of October 8, 2020: "Governor Andrew M. Cuomo announced that 145,811 COVID-19 diagnostic test results were reported to New York State yesterday—a new record high. In the top 20 ZIP codes in areas that have seen recent outbreaks - Brooklyn, Queens,and Rockland and Orange Counties - 7,349 tests were conducted, yielding 426 positives or a 5.8 percent positivity rate. In the remainder of the state, 138,462 tests were conducted yielding 1,410 positives or a 1.01 percent positivity rate;" AND

    - vii. WHEREAS, the Center of Disease Control and Prevention (CDC) confirmed that Covid-19 disproportionately affects communities of color; AND

- wHEREAS, NYC Covid-19: Data states, Hispanic/Latino have a total of 5,970 confirmed deaths and 1,264 probable deaths, Black/African-American have a total of 5,348 confirmed deaths and 1,435 probable deaths, White have a total of 4,909 confirmed deaths and 1,201 probable deaths, Asian/Pacific-Islander have a total of 1,435 confirmed deaths and 413 probable deaths, and Other/Unknown have a total of 1,653 confirmed deaths and 333 probable deaths; AND

- xiii. WHEREAS, "The second half of the CARES Act funding, which is \$118 million plus \$14 million from the Minority-Serving Institution (MSI) component of the CARES Act, is the institutional aid that will be allocated to the campuses;" AND;

- xv. WHEREAS, the lack of transparency and institutional supplemental aid is incomparable, aggravating, and an injustice to the student body at Baruch College, in addition to CUNY as a whole; AND

- xvi. WHEREAS, Hunter College of CUNY has implemented at their respective institution a re-envisioned CR/NC policy that accommodates the circumstances that Covid-19 and distance learning has had on their student body; AND

- xvii. WHEREAS, academic institutions such as Baruch College must safeguard the historical educational accessibility and success to communities of color and in general for the students.

- THEREFORE, BE IT RESOLVED, that the Undergraduate Student Government of Baruch College calls upon action to be taken by the Baruch College administration, specifically President David Wu as has been done by Hunter College and their respective administration headed by President Jennifer Raab and/or for Baruch College to go through the channel of bureaucracy to gain access to such policy known as Credit/No Credit (CR/NC) to be enacted by CUNY Central and Chancellor Felix Matos Rodriguez at Baruch College.

- xix. BE IT ALSO RESOLVED, the Undergraduate Student Government at Baruch College is unwilling to see a Fall 2020 semester with no implementation of the Credit/No Credit (CR/NC) policy and therefore is open to negotiations on the matter with the introduction of a compromise that consists of the implementation of a maximum 2 class policy of CR/NC, which would safeguard student wellbeing and success, in addition to adhering to institutional academic rigor.

- b. Erika: Do you know when Hunter implemented this policy?
- c. Richard: It was done very early in the semester, from what I gathered, because they had a certain deadline for near November. In all honesty, it's a disgrace that Baruch hasn't stepped up and implemented a similar policy given the long-term and dire circumstances as well, given everything they learned from how the situation was handled back in Spring 2020?
- d. Briana: Would you like for everyone who votes in favor of the resolution to sign their names on it?
- e. Richard: Yes, I just wasn't certain how table members would feel, but I think it's more than warranted given that we each represent 1000 students and their needs, and this is something that the student body has been calling on it as well.
- f. Kristina: For the Credit/No Credit, what happens to the classes that you need a specific average for? For example, when you start taking classes for your major, and you need to maintain an overall specific average. Would this policy be applied to those courses, or just others like capstones?
- g. Richard: We would follow suit with how it was implemented last semester, and on a case-to-case level. The policy overall stated it would acknowledge for the time being, and it is optional as well.
- h. Cindy: What letter grade would be considered for a "No Credit" qualification?
- i. Richard: Anything lower than a C. You can apply the "No Credit" option and retake it again.
- j. Alison: I feel like it should be stated again that this policy is optional for students. They don't have to do so if they don't want, but can potentially benefit students.
- k. Richard: Yes of course. As a society, we try to do things for the benefit of the people.

- 1. Steven: To show how effective this survey was, a lot of students have voiced their support for it and gratitude for USG, and I want to give a big thanks to Richard and Laiba for their work on this.
- m. Richard: Thank you. As mentioned, this virus has disportionately affected a lot of communities and the students and overall, I think this would be the best solution for students and as representatives.
- n. Irine: I want to add on that a lot of people who opt in for Credit/No Credit also seek academic advisement beforehand and to make sure it's a good option for them, in case they decide to go to graduate school or beyond and it may end up affecting them.
- o. Richard: Yes, that same guidance was mentioned and encouraged to students back in Spring 2020.
- p. Raphael: I monitor the Baruch subreddit, which is an interesting way to get some feedback from the student body. Normally, nothing on the site ever gets much engagement, but today the top post was "This semester should be Credit/No Credit" and people talking about their own experiences on it.

Richard: I just want to thank everyone who shared the post, who sent me their feedback on the survey, it was very insightful and to make sure we were delivering a survey that was both concise and informative and would bring about change in our community. A major shout out to Laiba for collaborating with me on this and helping out with the survey.
- s. Laiba: Thank you to the table and Richard for all the support. I can't wait to see the outcome.
- t. Richard: I know at times it might feel a bit defeating on whether or not this will be put into effect, but it will amplify our voices and make sure we are being advocated as students, and adding our perspectives as students on the matter. Be optimistic thinking the administration will be on our side, and they will make sure they do the best for our overall success.
- 3. Cindy Chen | Chair of Graphics
